





About PLANASA

PLANASA is a multinational **leader in the agri-food sector**, acknowledged as a global leader in the development of new varieties of berries.

For almost 50 years, as it has grown both in the USA and Europe, the group has faced continuing challenges as agricultural technology has matured.



The challenge

PLANASA is present in more than 25 countries, has 4.000 employees, and counts more than 225 registered varieties of crops in its portfolio. It is a **world leader in soft fruits** with offices in Spain, France, Italy, Poland, Romania, Belgium, Morocco, USA, Mexico, Peru, and China.

PLANASA faced the need to **unify and consolidate information on interactions with its customers**, to reduce
intercompany tasks, and improve sharing of information
across its companies. It also needed to unify support and the
set of IT tools used across the group and centralize its internal
IT team.

GOLIVE has worked with PLANASA to install the JD Edwards ERP and has accompanied PLANASA in its **process of expansion and internationalization**, implementing the ERP in all subsidiaries of the group and giving PLANASA a robust ERP capable of supporting its rapid growth.





The project

2013 Oracle JD EDWARDS Implementation from April 2013 to January 2014. The project is implemented in parallel for three companies in Spain and three in France.

2014 Stabilization and support and **ROLL-OUT IN POLAND** for sales and fiscal localization from September to December 2014.

2015 Oracle BI solution implementation from January to May and **BENELUX ROLL-OUT** from September to December.

2016 Implementation of the rest of modules in **POLAND** from January to June.

2017 ITALY AND CHINA ROLL-OUT from January to June.

2018 MOROCCO ROLL-OUT from January to June. **Endivias del Duero** implementation from September to December.

2019- 2020 ROMANIA ROLL-OUT from January to March 2019. **Field project and HR web digitization**, from April 2019 to April 2020. Version change to 9.2 from January to March 2019.


2021 MEXICO ROLL-OUT. GRUPO PLANASA model implementation with the 9.2 version from March to November.

2022 USA ROLL-OUT from May to November. GRUPO PLANASA model implementation with 9.2 version. Tools updating at the beginning of 2023 and **Orchestrator** development begins.

2023 PERU ROLL-OUT. Process underway for implementation in Peru.

Since 2014 systems support, and system monitoring since 2019.





Customer, supplier, and item master **standardization**, allowing consolidated exploitation and tracking by customer.

Processes **standardization** among group companies. Until the implementation of JD Edwards, there was no uniformity in sales, logistics, and financial processes. This was achieved by implementing JD Edwards across the different group subsidiaries.

Common database enabling a data mining and BI system, with cubes for sales, purchasing, finance, analytics, and inventory modules.

Financial consolidation system implementation and **group budget management** with Prophix.

Unified treasury management across the group with Sage XRT.

Documentation issued is uniform across companies. Multinational corporate image improvement as it no longer appears to clients as a sum of different companies.

Intercompany work reduction, avoiding double order entry and improving intercompany matching.

Base for the digitization of key processes across the organization. Field, warehouse,

Employee management through the **HR**web portal, as a single point of entry and
control for employees (social security
registration dates, production centers,
contracts). This has reduced the
administrative burden by introducing an
approval flow between operations and HR.

Expense digitalization with XPENDOR, reducing manual effort for processing employee expenses in all countries where it has been implemented.

Unification of user support and maintenance of IT tools across the group through centralizing with an internal IT team.

A **reduction in closing periods** has been achieved, with close information available within the first ten business days of the period worldwide.

Unified analytical processes that allow comparisons between the different countries of the group and unify closing procedures.

Integrated management of laboratory operations in JD Edwards field system.

Cost savings with the standardization of processes at a group level.




